

Rising Stars

General Rules and Guidelines

1. The Executive Director and Executive Producers have complete charge of all activities during the Miss Anaheim event. They have full authority to make decisions governing contact with the Rising Stars.
2. Parents/guardians will be allowed backstage **only** if asked by the Executive Directors, Princess Director, or other authorized agent of the Miss Anaheim Scholarship Program.
3. ALL RISING STARS when not with a parent or guardian will be chaperoned by the Rising Star Director and her assistants.
4. All problems should be immediately reported to the Rising Star Director. Regardless of how small or large a problem, please report it.
5. From the time a Rising Star arrives for the production until it is completed, a Rising Star is under the jurisdiction of the Miss Anaheim Rising Star Program and must abide by its rules and regulations.
6. Any Rising Star whose conduct is deemed unbecoming by the Miss Anaheim Princess Program will be asked to withdraw from the program.
7. Rising Stars must be present at the entire rehearsal to participate in the pageant. Please contact the Executive Directors or Rising Star Director for any personal concerns or scheduling conflicts.
8. TRANSPORTATION & MEALS: You must provide your own transportation and meals while in the Miss Anaheim Rising Star Program. Snacks may be provided. Please notify us immediately of any allergies.
